### GENERAL REGISTRATION INFORMATION

To register at the CASE member rate, your membership must be current through October 31, 2022. If your membership expires before this date, you must renew your membership online or on the conference registration form. You may also join as a new member and register at the discounted member rate.

Registration fees will be determined by the date forms and payment are received in the CASE office, not by postmark. Registration forms not accompanied by payment in full will not be processed. Checks and purchase orders may be made payable to CSTA. One purchase order may be used for multiple registrants; please reference the purchase order number on each registration form.

**Your registration fee includes more than 150 90-minute workshops, the General Sessions, Focus Speaker sessions, and access to the exhibit hall.**

### TICKETED EVENTS

Ticketed events (Awards Reception, Short Courses, and Evening Events) are not included in your registration fee. If you wish to purchase a ticket for a ticketed event, you must register for the conference. Please make your ticketed event selections carefully. **CASE is not responsible for schedule conflicts resulting from a registrant's selections and will not refund fees in such cases.** If you select a ticketed event that is sold-out or unavailable, you will be given the option of applying the funds to another available event or receiving a refund. If you choose to receive a refund and you paid by credit card or purchase order, your credit card charge or invoice will be adjusted accordingly. If you paid by check, a check refund will be issued.
